  - 5.1 <u>Section 8 Family Self Sufficiency Program</u> The Board approved the 2010-11 HACB budget in August 2010. This budget included, within the Section 8 Housing Choice Voucher Program budget, \$69,000 in funding from HUD in support of the FSS Coordinator position. Funding of the Section 8 FSS Coordinator position is subject to an annual grant application to HUD. In this year's preparation of the FSS grant application, it was determined that a Board Resolution was required, authorizing the application for funds. Such requirement was determined in reading HUD's Notice of Funding Availability (NOFA): "Governing body of the applicant's organization <u>duly authorizes</u> the application for federal assistance."
