# **MINUTES OF June 18, 2015**

Chair Moravec called the meeting of the Housing Authority of the County of Butte to order at 2:08 p.m.

# 1. ROLL CALL

#### 3. CONSENT CALENDAR

Executive Director Mayer informed the Board that the bid effort for Farm Labor Housing rehab construction has been put on hold pending resolution of applicable labor wage rates with USDA-Rural Development.

5.1 <u>Family Self Sufficiency Graduate</u> – The Board recognized the successful completion of the program by Family Self Sufficiency Graduate Grace Dwyer. She was unable to attend the meeting due to work obligations. Ms. Dwyer sent her regrets for not being able to attend, and her appreciation for the program.

# \*RESOLUTION NO. 4575\*

Commissioner Anderson moved that Resolution No. 4575 be adopted by reading of title only: "RECOGNITION OF FAMILY SELF-SUFFICIENCY GRADUATE GRACE DWYER". Commissioner Chambers seconded. The vote in favor was unanimous.

5.2 <u>HACB Audit</u> – The audited financial statements for the fiscal year ended September 30, 2014, for the Housing Authority of the County of Butte, and including the component units Butte County Affordable Housing Development Corporation and Banyard Management, were presented. Finance Officer Kemp noted that the Commissioners listed in the audit were as of the fiscal year end. This year's auditor was same as last year, and as such completed a very thorough audit. Therefore this year's audit contains additional required notes. Despite the comprehensiveness of the data shared with the auditor, there were no questioned costs or findings. Executive Director Mayer recommended that the Board read the Management Discussion and Analysis on pages 4 – 12 before Strategic Planning sessions. Page 8 shows improvement of net financial position. The only concerns of note are the viability of Farm Labor Housing operations and the uncertain federal funding stream.
